TRIP OVERVIEW:

The 68th Annual State FFA Land Judging Career Development Event will be held at Louisburg High School in Louisburg, North Carolina from November 10-12. Students will leave Thursday, November 10th and return November 12th.

This year, the North Carolina FFA Association will host a junior and senior division event. At-large junior and senior division teams will be allowed to participate in this event provided they register before the deadline. Junior division teams of three or four FFA members in grades six through ten will compete by completing the entire official land judging scorecard. Awards will be given to the top junior division and senior division teams. Alternate participants are not allowed at this event.

Eight students will be representing the Polk County High School FFA Chapter in the senior and junior divisions, respectively.
