TRIP OVERVIEW:

The NCFFA Camp will be held June 12-16 in Elizabethtown, North Carolina. The Polk County FFA Chapter will leave June 12th and return June 16th.

Forty-two students will be representing the Polk County High School FFA Chapter in the senior.

STUDENT and CHAPERONE COST:

Expenses:

- \$250/Cost per student – includes meals.
