## **Family Services**

### **Health and Safety**

- All sanitation inspections have been completed at each preschool site. The program did well. New guidelines were discussed and the program is working on how to plan for compliance.
- The PreK nurse has been doing education on prevention of illness as we enter the peak of the flu season. Handwashing activities are continuing in some classrooms.
- Courtney Edney has transferred to the nurse position at the middle school.
- We welcome Renee Souther who transferred from Tryon as our preschool/disabilities nurse.

#### **Education**

- 97% of families received a Fall TSG parent-teacher conference to discuss their child's strengths and areas for growth.
- Participated in Head Start review (Week of December 4-8)
- Completed initial Fall 2023 TSG Programmatic Data Analyses.
- Completed Monthly Office File Check for Education
- Monitoring Fall Parent-Teacher Conference Information—entered individual documentation into GoEngage for each child/family.
- New Preschool School Readiness Plan draft created for Policy Council Review. School Readiness Committee to meet in January, 2024; March, 2024; and May, 2024.
