Polk County Head Start Supplemental Grant Request for Playgrounds

The Office of Head Start makes available to offer one time funding to programs for the purpose of completing projects that are not covered in the Head Start grant.

Polk County Schools is in need of a complete redo on the preschool playgrounds at Sunny Vlew, Saluda, and Polk Central. The playgrounds were installed beginning in 2004 and have exceeded the life expectancy of a playground for young children.

The cost to do this project far exceeds the funds available to the program without seeking additional special funding. The program is requesting a waiver to the 20% Non-Federal Match as this is a project without funding available from the baseline grant.

The playground's original design was an addition to the existing K-5 playground at Polk Central in 2004. Over the years we have tried to improve and upgrade but now the time has come to redo this playground and make it specifically designed for preschool children with safety and appropriate equipment in mind.

Saluda

The playground was built in 2004 and over the years the equipment has become in need of repair, the rubberized surfacing is in need of replacement, and continued drainage issues need to be addressed. The cement trike path is buckling due to roots from a large tree and now this has become a tripping hazard.

Sunny Vlew

The playground at Sunny View was installed in 2004 and is in need of complete replacement. The structure needs to be replaced and the rubberized surfacing is in need of replacement. The concrete trike path is broken and cracked. Drainage is a problem at this site and this will be addressed in the replacement.
