- The Support Coach helped support child(ren) with behavioral or social emotional needs with visits to classrooms.

- Polk Central teacher Amy Crowder had a planting event on April 24. Mrs. Crowder read a book "Splat the Cat" and planted either snap peas, cucumbers or onions with her students. The students also took home a copy of the book and a planting activity for home.
