#### TRIP OVERVIEW:

Polk County High School Band students have the opportunity to attend a live production of the musical "Harry Potter and the Cursed Child" at the historic Fox Theatre in Atlanta, Georgia, as well as visit several other educational institutions in the city.

The trip will begin on Friday, March 20th at 8:30am. Our first stop will be the Georgia Aqarium, which is the largest aquarium in the United States. Students will see hundreds of different types of marine life, including beluga whales, manta rays, and whale sharks. Students will eat lunch at the aquarium, which is included in the price of the trip. We will check into the hotel in the late afternoon, after which we will have dinner at the Hard Rock Cafe, and attend the musical.

On Saturday, students will visit the Martin Luther King, Jr. Birthplace, and take a tour led by the National Park Service. Students will also tour the adjoining Martin Luther King, Jr. museum and the historic Ebenezer Baptist Church. Next, students will travel to the campus of the Georgia Institute of Technology (Georgia Tech). They will take a guided tour of campus and visit the student center, the Fine Arts building, the library, and other academic facilities on campus. Students will also eat lunch on campus. We will leave Georgia Tech at approximately 2:30pm and return to Polk County High School around 6pm.

The trip will be arranged through Burke Educational Tours, a subsidiary of Burke Christian Tours located in Maiden, NC.

#### **STUDENT and CHAPERONE COST:**

#### **Expenses:**

The total price per student will be \$415, based on quad occupancy.

This includes the cost of the motorcoach, the ticket for the aquarium, the ticket for the musical, lunch at the aquarium, dinner at The Hard Rock Cafe, a \$20 lunch allowance at Georgia Tech, and the hotel room. Students will not be required to bring any money with them for this trip.

#### **FUNDRAISING:**

Students with financial needs will be funded through fundraisers and/or scholarships and through Polk County Friends of the Band as needed. No child will be refused this trip because of an inability to pay.

#### **LODGING:**

Hotel to be determined by Burke Educational Tours (three-stars or higher)

#### TRANSPORTATION:

Students will travel in a Burke Educational Tours deluxe motorcoach operated by a professional motorcoach driver.

### **LUGGAGE RESTRICTIONS:**

Each traveler is restricted to one medium piece of luggage to go under the bus and one overnight/book bag to take on the bus.

It is the responsibility of the student and parents to provide any updated information in reference to student health/medical situations. If any changes have occurred since filling out the form in August, please note changes on the attached form (initialed by the parent), and return to Mrs. Benson

#### **DEPOSIT DUE:**

A \$100 deposit for students/parent chaperones will be due on September 1st, 2025

#### **BALANCE DUE:**

The following payment plan will be offered:

\$100 payment due by October 1st, 2025

\$100 payment due by November 1st, 2025

\$50 payment due January 8, 2026

\$65 payment due February 1st, 2026 (final payment may go down or be eliminated depending on fundraising efforts)

Per the tour company, a \$100/person deposit must be paid to Burke Educational Tours by October 1st, 2025. The final balance of the trip must be paid to BET by February 20, 2026. The payment plan above allows for some flexibility for parents who may need an extension on installment payments.
